A. Budget Request Summary

The California Highway Patrol (CHP) requests 10 positions and a \$7 million permanent augmentation from the Electronic Cigarette Products Tax Fund in Fiscal Year (FY) 2020/21 for the purposes of creating a task force charged with combatting illicit vaping device and product import, export, manufacture, transportation, distribution, and sales.

B. Background/History

Over the past several years, the popularity of vaping has greatly increased. Vaping is generally understood to be the act of inhaling an aerosol created by a vaporizer or electronic cigarette. The vapor may contain nicotine, delta-9-tetrahydrocannabinol, cannabidiol, and/or other substances. Unfortunately, this new popularity has led to the advent of an illicit vaping market, which many believe may be the cause of the numerous injuries and deaths associated with vaping nationwide. There are some indications these injuries may be associated with specific additives found in some vaping liquids (several reports cite vitamin E acetate), and/or vaping devices constructed with substandard and/or harmful materials. As of December 4, 2019, the Center for Disease Control places the number of electronic cigarette or vaping product use associated lung injuries at 2,291, and the number of deaths at 48.

Currently, a variety of state agencies are responsible for regulating vaping devices and products, including the California Department of Public Health (tobacco/nicotine and manufactured cannabis products), the Bureau of Cannabis Control (cannabis product sales and distribution), and the California Department of Food and Agriculture (cannabis and industrial hemp-based cultivation). In order to address the rapidly increasing youth use of potent nicotine-based vaping products, the Budget proposes a new nicotine content-based E-cigarette tax. The new tax will begin on January 1, 2021, and will be \$2 for each 40 milligrams of nicotine in the product. The tax fee will be used for administration, enforcement, youth prevention, and heath care workforce programs. A large part of the enforcement currently conducted consists of assessing fines based on the violation of administrative regulations.

Although the source of illicit vaping devices and products is not well understood, there are some indications illicit vaping devices and products are manufactured domestically and internationally. These devices are likely then imported, exported, transported, distributed, and sold (at illicit cannabis retailers and through other unregulated sellers) where they are consumed by the public. To mitigate the risks posed to public health and safety, the CHP will head a task force, in cooperation with the California Department of Justice (DOJ), for the purposes of investigating and disrupting the flow of illicit vaping devices and products to the public.

In addition to a request for funding, the CHP is also requesting a legislative amendment

to Section 22950.5 Business and Professions Code, as indicated below.

22950.5. For purposes of this division, the following terms have the following meanings:

- (a) "Department" means the State Department of Public Health.
- (b) "Enforcing agency" means the State Department of Public Health, [the Department of the California Highway Patrol,] another state agency, including, but not limited to, the office of the Attorney General, or a local law enforcement agency, including, but not limited to, a city attorney, district attorney, or county counsel.
- (c) "Smoking" means inhaling, exhaling, burning, or carrying any lighted or heated cigar, cigarette, or pipe, or any other lighted or heated tobacco or plant product intended for inhalation, whether natural or synthetic, in any manner or in any form. "Smoking" includes the use of an electronic smoking device that creates an aerosol or vapor, in any manner or in any form, or the use of any oral smoking device for the purpose of circumventing the prohibition of smoking.
- (d) (1) "Tobacco product" means any of the following:
- (A) A product containing, made, or derived from tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, including, but not limited to, cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, or snuff.
- (B) An electronic device that delivers nicotine or other vaporized liquids to the person inhaling from the device, including, but not limited to, an electronic cigarette, cigar, pipe, or hookah.
- (C) Any component, part, or accessory of a tobacco product, whether or not sold separately.
- (2) "Tobacco product" does not include a product that has been approved by the United States Food and Drug Administration for sale as a tobacco cessation product or for other therapeutic purposes where the product is marketed and sold solely for such an approved purpose.

Note: Use of brackets '[]' indicates an addition.

C. State Level Considerations

This proposal is in response to concerns raised by the Governor, Legislature, Health Agencies, and the public of California related to the injuries and deaths sustained by persons using illicit vaping products and devices. Illicit vaping poses a public health and safety risk due to the possibility of exposing users to toxic chemicals and has undoubtedly led to economic loss among legal businesses where consumers were driven to the illicit market. This proposal is consistent with the CHP's mission to provide the highest level of Safety, Service, and Security to the people of California, and in line with the CHP's goal to protect life and property. Ultimately, the creation of this task force will reduce the risk to public health and safety while encouraging consumers to choose regulated vaping devices and products.

D. Justification

This proposal requests funding for personnel, equipment, an interagency agreement with DOJ, and other costs necessary to successfully implement the task force, as described above. For these purposes, the CHP requests the following:

- One sergeant position to supervise task force investigative teams statewide.
- Nine officer positions to perform specialized criminal investigations and enforcement targeting illicit vaping device and product import, export, manufacturing, transportation, distribution, and sales. These investigators will work cooperatively with DOJ as a team to investigate and disrupt the delivery of illicit vaping devices and products to the public.
- Funding for an interagency agreement between the CHP and DOJ for the purposes of providing consulting services, including investigative support and other services, as appropriate/necessary. To ensure adequate statewide coverage and appropriate investigative capabilities, a minimum of eight DOJ investigators will be funded.
- Funding for equipment and general expenses in support of the task force.

E. Outcomes and Accountability

The CHP Task Force will work with DOJ (through an interagency agreement) to conduct criminal investigations related to illicit vaping operations for the purposes of preventing illicit vaping devices and products from being sold to the public. The CHP will collect data, using similar methods to those used in vehicle theft task force operations, for the purposes of conducting analysis.

F. Analysis of All Feasible Alternatives

1. Approve 10 positions and \$7 million permanent funding from the Electronic Cigarette Products Tax Fund in FY 2020/21 for the purposes of creating a task force charged with combatting illicit vaping device and product import, export, manufacture, transportation, distribution, and sales.

Pro: This option would allow the CHP, in cooperation with DOJ, to conduct criminal operations and disrupt the flow of illicit vaping devices and products to the general public. This option would provide the CHP with the resources necessary to conduct comprehensive investigations on a statewide scale.

Con: This option would obligate funds from the Electronic Cigarette Products Tax Fund.

2. Approve \$3.5 million in permanent funding in FY 2020/21 to fund 10 positions, associated equipment, and general expenses.

Pro: This option would provide limited resources for the purposes of conducting criminal investigations into illicit vaping device and product operations.

Con: This option would reduce the number of personnel available to the task force and reduce the effectiveness of the task force by removing support provided by DOJ.

3. Deny this request.

Pro: This option would not obligate funds from the Electronic Cigarette Products Tax Fund.

Con: This option would severely limit the ability of the CHP to conduct illicit vaping device and product investigations, thereby limiting the potential public health benefits associated with the establishment of a dedicated task force to combat this issue effectively.

G. Implementation Plan

This augmentation would become effective July 1, 2020, or upon enactment of the Budget Act of 2020, initial steps for establishing the task force will begin.

Within 120 days, the CHP will begin identifying and evaluating applicable existing statutory and administrative authorities. At the end of the 120 days, the Department will make legislative recommendations necessary to improve the effectiveness of enforcement operations.

Within 180 days, the CHP will begin hiring task force personnel and drafting the interagency agreement with DOJ. Additionally, the CHP will begin conducting necessary training and purchasing equipment.

Within 240 days, the task force will become operational and begin conducting investigations and enforcement operations.

Within one year, the task force will be fully operational statewide.
